## **ARDMS Announces the Development of the New Pediatric Sonography Certification Examination Coming in 2015**

ROCKVILLE, MD. (April 28, 2014) - The Board of Directors of the American Registry for Diagnostic Medical Sonography® (ARDMS®), has approved the development of the Sonography profession's first specialty examination in Pediatric Sonography (PS). The new Pediatric Sonography specialty is part of the ARDMS Registered Diagnostic Medical Sonographer® (RDMS®) credential and will in part include select areas of the existing Neurosonology (NE) examination content as well as other areas specific to Pediatric Sonography. The first Pediatric Sonography specialty examination will be administered in February 2015.

The Pediatric Sonography certification supports the current and anticipated needs of the evolving pediatric Sonography field. This changing specialty as well as input from a cross section of medical professionals guided the decision to incorporate select areas of the Neurosonology examination content into this new and comprehensive Pediatric Sonography certification.

ARDMS® Registrants who now hold the Neurosonology specialty certification will be able to utilize their NE specialty through 2021 or until their 10-year recertification cycle is completed. Visit [www.ARDMS.org/NERegistrant](http://www.ARDMS.org/NERegistrant) for more information.

Applicants or candidates who have already applied to take the Neurosonology specialty examination will need to pass the Neurosonology examination by the end of 2014. The last day to apply for the Neurosonology (NE) specialty examination is August 1, 2014.
